As Residents and neighbors of San Carlos, Mexican, American, and Canadians as well as other nationalities who live in San Carlos. We would, through this letter to express our outrage at how the most vital of natural resources in the desert, water, is being managed in San Carlos. By Mexican law and with no political intention we turn to you respectfully to make the following statements:

Mexicans know that these are distinct times where people recognize that they themselves are the repository of sovereignty.

Article 39 of the Mexican Constitution which reads:

TITLE II

CHAPTER I

NATIONAL SOVEREIGNTY AND FORM OF GOVERNMENT

ARTICLE 39. NATIONAL SOVEREIGNTY RESIDES ESSENTIALLY AND ORIGINALLY IN THE VILLAGE. ALL PUBLIC POWER EMANATES FROM THE PEOPLE ESTABLISHING FOR THE BENEFIT OF THIS. THE PEOPLE AT ALL TIMES HAVE THE RIGHT TO ALTER INALIENABLE OR MODIFY THE FORM OF THEIR GOVERNMENT.

I express to you that we; as neighbors of different sectors belonging to the municipality of San Carlos, Nuevo Guaymas Sonora Mexico, have a major problem with the service as well as the charges that go along with said service of water and effluent. We realize that the management of water is by the State Water Commission (CEA) to which you preside over.

The State Water Commission (CEA) does not give the community of San Carlos the kind of service that it charges for.

Many residents of the Ranchitos sector have no water pressure for days and sometimes full weeks. Nor is there drainage and sewerage service. Yet CEA is very specific and demanding in their collections of payments for said services that are not rendered.

In San Carlos (CEA) wastes water in an unconscionable and irresponsible manner, damaging the infrastructure of our town and and generating huge discomfort.

Indeed Governor, the purpose of this letter is to inform you of the inconformity that most of the residents of San Carlos have with the poor service and the ridiculous arbitrary and illegal overcharges of CEA. What bothers us the most is the illegality of CEA regarding the consumption of this vital liquid. In this context, Governor I want to express that CEA performs the service charges of drinking water in an office that is located in San Carlos Nuevo Guaymas and recently the billing relating to drinking water for many residents have been unrealistic amounts. In many cases bills that used to be 255 pesos a month suddenly jumped to 1500 pesos a month without any reason or fact of law for the overcharging, ie, those amounts are allocated on a whim and dogmatic by the administrator of the State Commission Water Engineer MARCO ANTONIO AHUMADA, who has demonstrated incompetence, insensitivity and indifference to the discomfort of the population of San Carlos and other problems that under his leadership.

I want to emphasize to you in the sense that the city of Guaymas, Sonora and within the law corresponding to the year 2014 established the parameters accurately and cost recovery for water service, and it is the case that MARCO ANTONIO AHUMADA who has a long history of imposing steep, reckless and

illegally excessive fees for the collection of service, a situation that is already causing deep unease among all neighbors of this population center.

That is why Governor we head to you and hereby request your intervention in this problem, and that investigate the overbilling of which San Carlos residents have been the object of and at the same time charge us water rates that are strictly established in the legislation.

I inform you that our position on this situation is strong and determined and we will find the means to be heard.

Without further ado I reiterate our consideration and thank you in advance for the attention you will give to this.
